Loréna suggests, and I agree, that we should continue working on the Declaration for the Transition to a Culture of Peace in the XXI Century, including a meeting with NGOs and local government networks in order to discuss and disseminate it.

Roberto and Myrian will meet soon with scholars and activists from Argentina, Colombia, Brazil and Mexico to plan strategies for disseminating the Declaration in Latin America. They will then share the strategy with Loréna and the rest of us, requesting that we propose additions to the strategy.

Roberto tells me that he is looking for funds to launch the website for the Declaration for which he estimates the total cost at about one thousand euros. I will promise to send him one hundred euros and perhaps others of you are in a good position to contribute as well. He will inform us how to send money.

As for the projectgs for a Mayor's Security Council and for a CPNN Africa, it seems there are not yet groups ready to undertake their development.

Joe Yannielli suggests, and I agree, that I should make my books available at a lower cost in ebook (Kindle) format.

Jo McAuley suggests, and I agree, that we should take part in the public consultation on the Declararation on Global Education to 2050. As Joe Yanielli requests, we would appreciate receiving the draft text.

Gwen invites me to meet with the young volunteers of Unis Cité, and I have agreed to do so.

Myrian suggests that we try again to hold a virtual meeting. I wil be pleased to take part, but we need to know if others of you are available, and, if so, when is a good time and date?

I look forward to your replies after which we can conclude the meeting.
